Proposed Rule Changes

Page 2 Section D.2: Add (C) to read: *All WAGS Rosters MUST include valid jersey numbers on the roster prior to the beginning of each season. Any player listed on the roster without a valid jersey number is ineligible for play until properly rostered.* *Approved as written*

Page 3 Section D.3 Add:*The deadline for submission of the Request Forms will correspond with the date of the Fees Forms as stated on the WAGS Calendar.*

Change to Read: *The completed Request Form will be returned by the Club Representative to the WAGS President for approval. The deadline for submission of the Request Form will correspond with the date of the Fees Forms as stated on the WAGS Calendar.*

Friendly Amendment: Remove “s” from Form: *Approved as amended*

Page 5 Section F Box: Delete: Asterisk (*)

Delete : “and”

Change to Read: *NO Player shall be registered who was born on or after August 1, 1993. All WAGS U-11 teams must have a minimum of seven (7) players born August 1, 1991 through July 31, 1992.*

Page 5 Section G Box: Delete: “from”

Change: “through” to “and”

Change: “U-14” to “U-13”

Change to Read: *The WAGS Board of Directors shall determine Division Structure prior to each season with the goal of providing balanced competition in each Division. Divisions in the Age Groups U-12 and U-13 shall have 10 teams.* *Approved as written*

Page 5 Section 4: Change: “U-14” to “U-13”

Change to Read: *Teams in the U-11 through U-13 Age Groups are expected to play both Seasons each seasonal year. Any team in these Age Groups not playing a Season must reapply as a new team through the Waiting List.* **Approved as written**

Page 10 Section K.Box: Delete: Entire Box

Change to Read: ***“In addition, the forfeiting team MUST notify the League President and their opponent 24 hours prior to the scheduled game time. Failure to do so may result in disciplinary action by the R & D Committee and may also result in a fine equal to that of a complete game’s fees.”*** **Approved as written**

Page 10 Section K.6: Delete: “In addition, the forfeiting team MUST notify the League President and their opponent 24 hours prior to the scheduled game time. Failure to do so may result in disciplinary action by the R & D Committee and may also result in a fine equal to that of a complete game’s fees.”

Delete: “or forfeiture” after (),

Delete: “or” after State Cup

Add: “ or ODP Games” after soccer in ()

Change to Read: Failure to notify your opponent of game cancellation (State Cup, High School soccer, ***or ODP games***), AFTER NOTIFYING THE LEAGUE PRESIDENT, will result in an automatic forfeiture. Failure may also result in fines equal to that of the complete game’s fees to the offending team. **Approved as written**

Page 10 Section K.8 Add: “within the League’s fifteen (15) minute grace period, may result in a forfeit. The score shall be recorded as a 0-3 loss for the forfeiting team.

Change to Read: “Failure of the home team to provide the game ball, a PROPERLY LINED AND CUT FIELD, nets and corner flags, ***within the League’s fifteen (15) minute grace period, may result in a forfeit. The score shall be recorded as a 0-3 loss for the forfeiting team.”*** **Approved as written**
